**Please read and follow instructions when filling out entry forms to ensure contestant will be eligible to compete.**

### **CONTESTANT INSTRUCTIONS:**

***Return All Required Forms To Your Local Extension Office By May 1<sup>st</sup>***

1. Double check your entry form for accuracy and completeness before mailing. **Incomplete/inaccurate entry forms** will be assessed a **re-processing fee of \$5** and may cause you to **not be entered** in the Finals Rodeo. **All entry forms** received **must contain pgs 3, 4, 5, & 6; ANY missing pages** will constitute an **incomplete form**.

\_\_\_ **Stanley County Fairgrounds Waiver and Release Agreement** (pages 5 & 6) are completely filled out:

  - If contestant is under 18 years of age:
    - Both pages need to be completely filled out
  - If contestant is 18 years of age or older:
    - Page 5 needs to be completely filled out
    - Page 6 just needs the notary section completed starting with "State of \_\_\_\_"
- b) The page 5 needs:
  - The date the form was signed by the 4-H contestant (in the presence of the notary) placed in the "This Release is executed on \_\_\_\_\_, 20\_\_\_\_, by" section.

### **ENTRY FEES**

1. Individual Contestant Payment is done at Finals "check-in"
  - a) Payments can no longer be made for multiple contestants on one check/money order/cash/etc.
  - b) Payments (including cash) must be for exact amount as no funds will be available for receiving change/cash back. Any "over-payment" will be automatically considered a contribution.
2. If a contestants entry fee is returned to the Finals as NSF or for any other reason, that contestant will be on the NOT in good standing list and ineligible to compete in 4-H rodeos for the following year until this has been satisfied.
3. Registration will now be located under the grandstands for Friday & Saturday morning.

**NOTE: If a contestant does not wish to enter the finals or has event/events that they wish to not enter then they will have to notify the Finals secretary via e-mail first: [sd4hfinals@hotmail.com](mailto:sd4hfinals@hotmail.com) with a hard copy to follow to: SD 4-H Finals Rodeo Secretary, ATTN: Paula Lind, PO Box 517, Ft. - a) **If they do not notify the secretary prior to the finals draw, then the contestant is responsible for the entry fees.**

## TEAM ROPING CHANGES

### 1. Team Roping Partner and Header/Heeler Position

- a) Team ropers will be entered for the finals based on **the 1<sup>st</sup> regional rodeo results where the team qualified;**
  - If the header/heeler information is not accurate, changes need to be submitted to Finals rodeo secretary by **August 8th** deadline via one of the below options.
    1. Team Roping Correction Forms would be available via the web site
      - This form can be submitted via an attachment on an email to [sd4hfinals@hotmail.com](mailto:sd4hfinals@hotmail.com)
    2. Team Roping Correction Forms would be available via extension office
    3. Team Roping Corrections will NOT be accepted via a phone call.

## PERFORMANCE SCHEDULE AND TRADE OUT RULE

### 1. Setting of Contestant Performance Schedule/Contestant Trade Out Rule

#### a) Qualifying Events

**Events that qualify** for the official school/sports trade out include orientations (i.e. for a college/university/technical school) that are held on the day of competition, high school athletic games, and high school competitions (i.e. band, debate, golf meets, football games, volleyball etc.).

**Events that DO NOT qualify** include practices, classes, any non-school related event, and any post high school event (including school attendance/sporting events).

**Events that qualify** for the major medical conditions/treatment trade out include any life threatening condition requiring a medical appointment on a particular day or a scheduled treatment that cannot or should not be switched to a different day.

There will be **NO EXCEPTIONS** to the above defined events.

#### b). Setting of Contestant Performance Schedule Before the Draw

Submit to Finals rodeo secretary by 6pm CT on the Monday following first full weekend in August.

**We encourage all contestants** who have these conflicts to send a letter\*\* confirming the conflict via e-mail first to [sd4hfinals@hotmail.com](mailto:sd4hfinals@hotmail.com) with a hard copy to follow: **SD 4-H Finals Rodeo Secretary**, PO Box 517, Ft. Pierre, SD 57532. Please indicate which performance (Friday/Sunday or Saturday AM/Saturday PM) in the letter where the conflict is. This guideline allows us to set the contestant in the preferred performances with **NO further involvement** from the contestant.

**NOTE:** In the unlikely event that performances would not be evenly drawn due to contestants setting their performance schedule within the above guidelines, the Rodeo Secretary will make it even by a random draw. The contestants selected from the random draw will need to pursue the trade out rules outlined below and will be contacted by the Rodeo Secretary to alert them of this instance.

#### c) Contestant Trade Out Rule After the Draw is Posted

In the instances where the conflict was not resolved by setting contestant performance (see above).

1. Obtaining a letter\*\* stating the conflict
2. Arranging to have the letter e-mailed to the Rodeo Secretary
3. Finding contestants in the performance they need
4. Obtaining necessary phone numbers
5. Making contact with other contestants until a trade is obtained
6. Verifying other contestant(s) has confirmed trade with rodeo secretary.
7. Confirming the trade is complete with the rodeo secretary.

**No trades can be verified before the letter is received. Trade deadline is August 15th at 10pm Central Time  
NO EXCEPTIONS**

\*\* Please follow the appropriate guideline below.

**\*For school/sport events, a school official** must document **on school letterhead paper** that the contestant has a conflict with an official school activity. We may confirm this conflict by calling the school or coach.

**\*For major medical conditions/treatments, the doctor's office** must document **on their letterhead paper** that the contestant does have a medical appointment/treatment that may conflict. We may confirm this conflict by calling the contestant's local extension office.

## SCHOLARSHIPS

Scholarship forms are available at your local Extension Office or the 4-H Rodeo website, [sd4hrodeo.org](http://sd4hrodeo.org), for High School Seniors and college/university/technical institute freshman who will be participating in the 2011 Finals Rodeo.

**Deadline** to turn in completed **scholarship forms** is **August 1, 2011**.

## STALLS

Due to limited space, **all horses need to be stalled with the third party vendor, tied to a trailer, or kept off site overnight. Absolutely no pens of any nature will be allowed on the grounds with the exception of the vendor pens.** With the number of pickups, trailers, and horses on the grounds; it would be appreciated if everyone could utilize your space as efficiently as possible. Please use as little space as you can to ensure all contestants have room to park their pickups and trailers.
