

**Lincoln County Planning and Zoning**

The Lincoln County Planning and Zoning Commission met at 7:00p.m on Tuesday February 21, 2006 at the Lincoln County Extension Office, 200 East 5<sup>th</sup> Street, Canton, SD.
